Dolbear attended the Beaulieu Estate end of year review, at which Mr Russell Bowman provided the key progress and events across the year, taking into account the disruption due to the pandemic. As part of the public participation the Residents Association expressed concerns about the caravanning camping site in Hides Field. The success of the Beaulieu Fete was also noted, as was Beaulieu's growing reputation for musical performance. It was also recognized that it has been a difficult trading year for the High Street and the work the Council is doing in establishing a website and social media to support businesses more broadly in Beaulieu was noted at the meeting.

		JUBILEE CELEBRATION PROPOSALS The council would initiate some community meetings to start the planning and preparation for the Queens Platium Jubilee Celebrations on 2-5 th June and it was agreed that it would pay for the hire of Beaulieu Village Hall for that purpose. It was also agreed that this would be best run under an independently chaired committee. There were 4 aspects that the council agreed to suggest to the community being: 1) celebratory party with invitations to everyone living in the parish (estimated 800); 2) A commerative bench that could be placed in the Beaulieu Twinning Garden, which is in much need of refurbishment for the use of parishioneers and visitors;	
		3) Commerative mugs for Beaulieu children in the parish (including the school); and 4) Planting trees. Cllr. Hubbard agreed he would pass these suggestions to the organising committee when established.

With the onset of the increase in covid risks there has been a reinstatement of covid precautions introduced. Explained that many councils are organising celebratory Jubilee parties and other commerative items including tree planting. Cllr. Hubbard confirmed that some early proposals are under consideration and will be discussed in more detail at this meeting. There was a general discussion around the provision of charging points for electric vehicles. Cllrs. Mans explained that HCC approach has been to put in the higher quality charging units which could provide a substantive charge in 30/40 minutes, rather than cheaper options which take many hours. The council noted that any such equipment is currently outside the reach of its budget and also dependant on the right power supply.
