## 798. UPDATE FROM PC TILBURY

3 thefts from Shatterfield car park by Beaulieu Road. Asked Mr.Knight to let Estate workers to be on the look out for discarded handbags. Also theft from Kings Hat and ipod taken from a visitor to the Museum. Thieves had tried to take lead from school, but not taken and left on ground. Outboard stolen from Thorns Beach, recovered from property in Totton but cannot

prove theft. Said next week she will use the speed laser in the High Street, between 6 - 7.30a.m. Said

Inspector Katherine Willoughby, our new PC and Community Support Officer will attend next meeting. Said new PC will cover Beaulieu and Marchwood, but looking to increase to Hollands Wood, taking in Ashurst and Rownhills.

## 799. RECENT DEVELOPMENT AT BEAULIEU CEMETERY

Mr. Norris said that whilst he was at the Vicarage a funeral director told him that he was trying to bury someone in Beaulieu Cemetery and was told that it was now full and NFDC had closed it to any new burials. He spoke to Cllr. Vickers who talked to NFDC and he said it was just 'unjoined up thinking'. Said more land allocated to cemetery by the Estate, which will happen subject to NFNPA planning approval for extension to graveyard into field alongside. It will be a very long lease and the only thing the Estate has asked for in return is to come up with a plan of how they can deal with all the fallen down headstones. They have

been pushed over due to Health and Safety reasons. Also asked them to look at the flooding issue. They will report back at the end of September.

# 800. WEBSITE MEETING

Held on 1st August - attended by Mr.Norris, Mrs. McCafferty, Mrs. Shanks, Trevor Smith and John Pockett. Re: existing/future website. Mr. Norris feels we need to put alerts on to tell the whole parish what is happening. All residents to have access to a parish website and said we have a duty to do this under e-government. They want more parish councils on website and to use more information technology to communicate with their parish. Trevor came with a mock-up website and to drive traffic into this he did some rather good things, like live weather forecast, tide timetables etc. This will cost very little. Feels councillors will need to put info on and asked 'do we allow village organisations to post on there themselves'? Cost max. £1000 - £800 is fixed price - to build, training and support. Take 3 weeks to develop. Talked about going through HCC server. Mrs. McCafferty asked NFDC what parishes use their site and she said quite a few, which she looked at and said they all look like our existing website. Mrs. McCafferty and Mrs. Shanks kindly offered to input the information. Mr. Norris will let councillors have website address so that they can look at the mock-up and consider for next meeting, where a decision will be made. Sub-committee to meet again on Friday 13th Sept.

# 805. QUESTION TIME

Mr. Fairweather asked what is happening re the listed building consent for signs.

Mrs. Pearson said she had no news. Clerk to chase.

Mr. Gibbs mentioned the ditches in Furzey Lane and the fact they keep flooding and could we do anything about it. Mr. Knight said the ditches were the responsibility of the owners. Mr. Norris said he would talk to the owners of Mares Tails. Said the no parking' sign in Firestation Lane is old and small and needs replacing.

Mrs. Shanks mentioned the 'leaving' event for Carol, Andy, Jo and two others. Said we would hold this in October.

Mrs. McCafferty mentioned the new post box in Dock Lane and thinks it is too near the gate when opened and needs moving about 2' away.

Mr. Weiss mentioned the speed gun. PC Tilbury has tried to talk about this, but at the moment has not got anywhere.

Mentioned getting a 20mph speed limit through the village, but Ken has previously that you cannot go from 40 - 20. Have to go in steps, say 30 from top of Hilltop. Will look at this again when PC Tilbury has used the speed gun in the village.

Said we have a rat problem in the village. Mrs. Pearson said they have acted on this and put bait boxes down. Problems behind the Learning Garden and Housing

Association Houses. Clerk to write to NFDC Environment Health and ask for advice. Should we write to the residents of the Housing Association houses?

Mentioned large events at Beaulieu and lack of communication with Estate, and could we have regular meetings to discuss events. Mrs.Pearson said this already happens and Mrs. Green and Mr. Dovey have attended in the past. In future Mr. Weiss and Mrs. Shanks will attend.

Mentioned the bell bollards and should the wooden posts be replaced by black cast iron?

Mentioned signs posts around Bucklers Hard, missing or knocked over. Clerk to write to Highways. Said the phone in the phone box in the High Street is not working. Should we have this removed or resited? as it detracts from the Twinning Garden. Agreed visitors love it and it should stay. Said can we find a benefactor to pay for the costs to have this smarten up.

Asked about changing the running order of PC meetings. Mr. Norris said we would defer this to next meeting.

Said Wilts & Dorset bus stop sign at Hilltop needs to be straighten up. Clerk to write.

Mr. Norris mentioned the pill box in Fire Station Lane need tidying up.
