### 1038. PUBLIC PARTICIPATION

Mr. Beaumont mentioned Neighbourhood Watch and said needs to set up a meeting with PC Support Officer, Dan Carling, and Cllr. Weiss, who we hope will mastermind this.

CCTV in the village – will be interesting to hear from Cllr. Fairweather at the next meeting about how this is working.

Said PC Jason Eastwood is Beaulieu's new police officer.

Mentioned the trucks still coming through the village too fast by the Montagu Arms. These lorries are George Jenkins from the IOW, said they are excessively dangerous at 7.10a.m. Cllr. Steele said the CCTV will now pick these up. Clerk to write to Mr Jenkins expressing our concern.

Said cattle grid at Bulls Hill is still 4" lower than the road and dangerous. Engineers have been testing it.

Cllr. Norris welcomed Mark Grindrod, he has come along tonight to see if he would like to join us.

# 1040. **NEW FOREST DISTRICT COUNCILS REPRESENTATIVE'S REPORT** Cllr. Vickers said at the next meeting he hopes to bring Michael Harris, the Conservative candidate. Says the council is winding down, no decisions being

made as coming up to elections. Said Marchwood Military Port had two bidders, one dropped out, so almost certainly ABP, government will make a decision 2<sup>nd</sup> week of March and said this will upset lots of people re: the increased traffic. ABP are establishing themselves in a big way on the waterside. Debate going on about Navitus Bay, thinks will get the go ahead because there is a 'green agenda' and government want to shut down coal fuelled power stations. Said they have reduced the size of it, now further off shore. Said NFDC is the most affected council and it will be a big event when it happens. The infrastructure land-side will take approx. 2 years.

There has been an application for a solar farm at Exbury, but has been overwhelmingly turned down. Inchmery House has also had a big development turned down.

# 1042. TALK BY GAIL ALLEN, AGE CONCERN

Said the Village Agent project is HCC supplied and funded, and now recruiting volunteers to go and see old people face to face in rural areas to give them someone to chat to – someone they may have seen in the village. Last year had 12 volunteers across Hants, now have 40. Ideally looking for 2 village agents per Area. They have David and Rose for Exbury, Lepe, Calshot and possibly Fawley. This is to sign-post older people to information, so they can remain independent i.e gardening, , benefit allowances, handy people, getting out in the community, attending lunch clubs, coffee mornings, leaflets, parish magazines, enabling them to reach people and information. If anyone is interested then Age Concern will send an application form, job description and will come and visit and talk about the role. They do a DBS check and take up two references, and give them help to get started. If we know anyone who is interested, please ask them to contact Gail. She asked if we have a problem in this area, as they do receive a lot of enquiries from the NF area. Cllr. Steele asked how the village agent gets all the information needed. Gail said they can go on training courses and have back up to help them. Said it is not advice giving it is signposting to get them to the right help. Said it would be good if we could link Beaulieu and East Boldre. Cllr. Norris said we have a meeting with EB re the SLR and will mention it. Said the Devonshires would like to be involved. Said the Luncheon club at EB village hall has moved to the Turfcutters on a Friday. Mr. Marling-Roberts said he would be willing to pay for tea etc. Cllr. Norris said you should be applauded for wanting to help and said BPC are behind this. Cllr. Knight said there are more elderly in EB who need help. Cllr. Norris said it might be a good idea to talk to St. Pauls Church at EB and the Abbey Social Committee.

Norris said we have a vested interest to use it again, but does cost money to move it – need to see the level of interest from the other two parishes. Cllr. Norris suggested 20/23/27 February and 2/5 March. Cllr. Norris said he was busy and asked Cllr. Shanks if she could attend. Cllr. Norris to contact them and wonders if we can

delegate this project to Cllr. Weiss. Cllr. Shanks said when the SLR is discussed we only talk about deploying it at the bottom of Palace Lane hill, but speeding and accidents happens on the bypass, but this is never considered. Cllr. Norris mentioned the fatalities on the Bucklers Hard Road. Said there is strong pressure by the community of EB about the speeding by the shop and garage and deaths of ponies. Discussed new position for SLR. Cllr. Vickers says it takes a long time to get a new sleeve, but wonders if we already have a sleeve on the bypass. HCC
